## 5 TERMS

**Title:** You must provide a copy of the vehicle title (front and back) with this request. All vehicles must have a clear U.S. title in the seller's name.

**Photos:** Please submit photos of your vehicle with this request (the photos shall not contain any watermarks, logos, and/or other marks). Six shots of the vehicle are required: front 3/4, back 3/4, side view, interior, engine and a picture of the VIN. Upon submission of this form, you agree that Barrett-Jackson may use any photos or other materials submitted for promotion and advertising of the sale of the vehicle. You certify that all photos are true and accurate representations of the vehicle you wish to consign to Barrett-Jackson, and you warrant and represent that you own the photos submitted herewith and that Barrett-Jackson's use of the photos will not infringe the rights of any third parties.
